

2015-06-19 Report No. 21/2015: Change of interest on the bonds series INGBS191219.

The Management Board of ING Bank Śląski S.A. hereby communicates that following the commencement of a new coupon period and determination of a new WIBOR rate for 6M deposits for that period, the interest for the bonds series INGBS191219 of the total par value of PLN 300,000,000.00 as issued by the Bank on 19 December 2014 under the *Own Debt Securities Issuance Programme of ING Bank Śląski S.A.* should change as of 19 June 2015. The bonds interest for the subsequent coupon period is 2.53% per annum. The next coupon date falls on 19 December 2015. The other rights under the said bonds remain unchanged.
